



Independent Contractors Agreement

WHEREAS, the Company is engaged in the non-profit business of educational youth soccer;

WHEREAS, the Company desires to engage the Contractor to perform services for the Company;

NOW THEREFORE, in consideration of the foregoing and the mutual benefits herein contained, it is hereby agreed as follows.

1. SERVICES

Company retains Contractor to perform the services as described below (hereinafter referred to as the Services) and Contractor agrees to perform Services for the Company according to the terms and conditions set fourth in this agreement.

2. DESCRIPTION OF WORK

*Officiate youth soccer league games for Heartland Soccer Association on an as needed basis. Correspond with Heartland Soccer Management to ensure up to date knowledge on league play guidelines and expectations of position.*

*The contractor agrees not to say anything that may be considered disparaging about Heartland Soccer Association. The contractor understands and acknowledges that disparaging comments can be very harmful and could cause harm and substantial damages to Heartland Soccer and/or its vendors.*

COMPENSATION

Company shall pay Contractor and Contractor shall accept from Company as full compensation for all services to be rendered by Contractor as outlined below:
